This ITB will be effective for three years, beginning August 1, 2023 through July 31, 2026, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District, for up to \$200,000.00, for the first year of the base contract period of August 1, 2023 through July 31, 2024. Products include a variety of foods that are gluten and dairy free to continue serving students with food allergies.
