Approval to renew ITB No. B207382JC for Paper Products for District Warehouse Operations (DWO), awarded to All Florida Paper, LLC located in Miami, FL, Imperial Dade, LLC located in Miami, FL (formerly known as Cosgrove Enterprises, Inc.), Fastenal Company with locations in Lee County, and ODP Solutions, LLC with locations in Lee County, for the third and final renewal period of November 17, 2023, through November 16, 2024, for up to \$1,500,000.00, pursuant to the same terms and conditions as previously approved by the Board. Paper products to be purchased and delivered include, but are not limited to: jumbo roll toilet tissue, standard roll toilet tissue, paper towel rolls, and multi-fold paper towel rolls. Approval authorizes the Superintendent to execute all

related documents.

Invitation to Bid No. B207382JC is for Paper Products for District Warehouse Operations (DWO). Paper products to be purchased and delivered include, but are not limited to: jumbo roll toilet tissue, standard roll toilet tissue, paper towel rolls, and multi-fold paper towel rolls. On November 17, 2020, this ITB was awarded to All Florida Paper, LLC, Cosgrove Enterprises, Inc., Fastenal Company, Imperial Bag & Paper Company, Office Depot, LLC, and ThreeZ Company, LLC for a one-year period, beginning November 17, 2020 through November 16, 2021, and renewed through November 16, 2023, with one more renewal option available. It is recommended the Board approve the renewal with All Florida Paper, LLC of Miami, FL, Imperial Dade, LLC of Miami, FL (formerly known as Cosgrove Enterprises, Inc.), Fastenal Company with locations in Lee County, and ODP Solutions, LLC with locations in Lee County (formerly Office Depot, LLC) for the third and final renewal period of November 17, 2023, through November 16, 2024, for up to \$1,500,000.00, pursuant to the same terms and conditions as previously approved by the Board. On March 12, 2021, Cosgrove Enterprises, Inc. was acquired by Imperial Dade, LLC. Imperial Bag & Paper Company and ThreeZ Company, LLC declined the offer to renew.
