resources of the applicable locations.

Recommended Action

Approval to increase the previously Board approved amount of \$4,100,000.00 by \$2,400,000.00, up to \$6,500,000.00, with Bateman Contracting, LLP of Fort Myers, Big League Builders, Inc. of Fort Myers, FL; Pavement Maintenance, LLC of Fort Myers, FL; and Tobler Construction, Inc. of Fort Myers, FL; for the period of November 21, 2023 through April 18, 2024, pursuant to the same terms and conditions as previously approved by the Board. The \$2,400,000.00 increase is requested due to additional services required by the Maintenance Services Department. The anticipated projects include, but are not limited to:

• \$2,000,000.00 - South Fort Myers High School: Running track

• \$400,000.00 - Day to day repairs

Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N207380RC is for Paving Services. Services include blacktop overlay, seal coat, resurfacing of parking lots, driveways, D-curbing, borders of parking lots, car stops for parking areas, running tracks, tennis courts and other paving projects. On April 13, 2021 this ITN was awarded to Bateman Contracting, LLP of Fort Myers, FL; Big League Builders, Inc. of Fort Myers, FL; Pavement Maintenance, LLC of Fort Myers, FL; and Tobler Construction, Inc. of Fort Myers, FL; for the period of April 19, 2021 through April 18, 2024. The \$2,400,000.00 increase is requested due to additional services required by the Maintenance Services Department. The anticipated projects include, but are not limited to:

- \$2,000,000.00 South Fort Myers High School: Running track
- \$400,000.00 Day to day repairs
