Budget Source	The increase of up to \$275,000.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for a one-time approval to increase the previously Board approved amount of \$475,000.00 by \$275,000.00, for a total up to \$750,000.00. Funds will only be expended within the existing resources of the applicable Location.
Recommended Action	Approval to increase the previously Board approved amount of \$475,000.00 by \$275,000.00, up to \$750,000.00, with Absolute Telecom & Electric, LLC of Hialeah, FL; Accurate Power and Technology, Inc. of Eustis, FL; and Taylor Sudden Service, Inc. of Louisville, MS; for the period of November 21, 2023 through May 24, 2024, pursuant to the same terms and conditions as previously approved by the Board. For this current bid period, generator projects were higher than originally estimated on account of escalation costs; therefore, the \$275,000.00 increase is requested to allow for additional Maintenance Services Department day-to-day services and/or repairs that could arise from periodic emergency generator testing. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N207392RC is for Generators - Purchase, Maintenance and Repair. Services include emergency generator repairs and routine maintenance on large-scale emergency generators at District shelter facilities as well as the option to rent and purchase new generators. On May 25, 2021 this ITN was awarded to Absolute Telecom & Electric, LLC of Hialeah, FL; Accurate Power and Technology, Inc. of Eustis, FL; and Taylor Sudden Service, Inc. of Louisville, MS for the period of May 25, 2021 through May 24, 2024. The \$275,000.00 increase is requested due to additional services required by the Maintenance Services Department for day-to-day repairs

It is recommended the Board approve the increase to the previously Board approved expenditure amount of \$475,000.00, by \$275,000.00, up to \$750,000.00, with Absolute Telecom & Electric, LLC of Hialeah, FL; Accurate Power and Technology, Inc. of Eustis, FL; and Taylor Sudden Service, Inc. of Louisville, MS; for the period of November 21, 2023 through May 24, 2024, pursuant to the same terms and conditions as previously approved by the Board.
