## **Bidders' questions/issues and District answers:**

- Q1. In reviewing the subject invitation to bid, I see that there is a requirement for automobile liability insurance. My company has no vehicles so I would like to know if this particular requirement is one with any flexibility
- A1. Yes. Attach a notarized statement with the following information:
  - 1. Company does not own or utilize company vehicles for their business.
  - 2. Vendor will not be using any vehicles to provide services for this solicitation. If this should change, a copy of the Certificate of Insurance must be provided immediately.
- Q2. If you can clarify or explain the following statements. I would like to make sure I put the correct information.
  - 1) Balance of line percentage discount (BOL). from page 21
  - 2) Balance of Line: from page 21 & 22 under the Catalog/Manfacturer, Minimum percentage discount area.
- A2. Q2.1. Any item in the catalog not listed in the above percentage discount. Q2.2. Any item in the catalog not listed in the above percentage discount.
- Q3. I have works comp, and general liability insurance and of course auto insurance, but what is other insurance? I have a personal umbrella policy, should that work?
- A3. Yes.

- Q4. Also, what do you guys need for indemnification?
- A4. As stated on Attachment C (Section 3-Indemnification) Vendors signature validates this requirement. No other information is required for indemnification.
- Q5. What do you mean by Lee County school board should be named as certificate holder?
- A5. The School Board of Lee County shall be listed on the Certificate of Insurance as a Certificate Holder. Example:
