Approval to award ITB No. B237453JA for USDA Processed Commodity Cheese, to ES Foods and Land O'Lakes, Inc., as primary vendors and Bongards Creameries, Inc., and JTM Provisions Co., Inc., as secondary vendors, as indicated on the attached tabulation sheet. This ITB will be effective for three years, beginning July 1, 2023 through June 30, 2026, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District, for up to \$1,500,000.00, for the first year of the base contract period of July 1, 2023 through June 30, 2024. This ITB is for the processing of "raw" bulk commodity cheese into value-added, finished, commercial products. USDA approved items include sliced cheese for made to order sub sandwiches and cheeseburgers, shredded mozzarella and cheddar cheeses for salad and taco toppings, cheese sauce for macaroni and cheese and nachos and cheese sticks. Approval authorizes the Superintendent to execute all related documents.

Invitation to Bid No. B237453JA is for USDA Processed Commodity Cheese. This ITB is for the processing of "raw" bulk commodity cheese into value-added, finished, commercial products. USDA approved items include sliced cheese for made to order sub sandwiches and cheeseburgers, shredded mozzarella and cheddar cheeses for salad and taco toppings, cheese sauce for macaroni and cheese and nachos and cheese sticks. It is recommended the award be made to ES Foods and Land O'Lakes, Inc., as primary vendors and Bongards Creameries, Inc., and JTM Provisions Co., Inc., as secondary vendors, as indicated on the attached tabulation sheet, effective for three years beginning July 1, 2023 through June 30, 2026, with renewal options for three additional one-year periods, for up to \$1,500,000.00, for the first year of the base contract period of July 1, 2023 through June 30, 2024. 60 vendors were notified of the ITB, four vendors submitted a bid, zero vendors submitted a No Bid, and 56 vendors did not respond.
