Approval to piggyback Hernando County Schools ITB No. 23-785-40, for Classroom Instructional Materials, Supplies and Equipment Catalog Discounts, anticipated to be awarded to multiple vendors, for the period of July 1, 2023 through June 30, 2024, for up to \$3,000,000.00, with an option to cancel if deemed to be in the best interest of the District. This ITB supports the ability to purchase classroom materials, supplies and equipment at a catalog discount. This piggyback is popular and highly utilized by the District's Bookkeepers for a variety of products including, but not limited to, classroom equipment/supplies, science and art supplies, speech and language products, STEM materials, and sporting equipment. Approval authorizes the

Superintendent to execute all related documents.

Hernando County Schools ITB No. 23-785-40, for Classroom Instructional Materials, Supplies and Equipment Catalog Discounts, is anticipated to be awarded to multiple vendors for the period of July 1, 2023 through June 30, 2026, with an option to renew for one additional 3-year term. This ITB supports the ability to purchase classroom materials, supplies and equipment at a catalog discount. This piggyback is popular and highly utilized by the District's Bookkeepers for a variety of products including, but not limited to, classroom equipment/supplies, science and art supplies, speech and language products, STEM materials, and sporting equipment. This ITB is anticipated to be Board approved by Hernando County in June, 2023. It is recommended that upon approval, the Board approve this piggyback, for up to \$3,000,000.00, for the period of July 1, 2023 through June 30, 2024, with an option to cancel if deemed to be in the best interest of the District.
