## ARTICLE 5 - General Employment Practices

## ARTICLE 7- Work Schedule

## Options

1. Faculty meetings limited to two (2) per month scheduled in advance, however, the instructional leadership team may call additional meetings. Faculty meetings or in-service trainings may not be more than 45 minutes in duration.
2. Virtual instruction staff will be provided a virtual option for any mandatory professional development or meetings to optimize participation and effectiveness.
3. Notice for mandatory meetings shall be provided at the start of each semester on the calendar developed by the School Calendar Committee. Teachers are not required to attend meetings and similar functions not expressly stated on the school calendar. An emergency meeting may be called at the discretion of the principal.
4. PLC meetings should last no more than 30 minutes per week, except where explicitly waived using the waiver of contract language in Article 13.05.
5. Teachers shall attend school related events, including but not limited to, curriculum nights, open house and similar activities, no more than two (2) times per semester, except where explicitly waived using the waiver of contract language in Article 13.05.

Teachers are not required to attend outside events not expressly indicated in the school calendar developed by the School Calendar Committee provided at the start of each semester.
