Invitation to Negotiate No. N207391DG is for Wide Area Network (WAN) and Internet Services. Services include wide area network (WAN) and internet to support approximately 100 District sites. Services enable internet access for all District locations. The District is eligible to receive federal funding for approximately 90% of the project cost for Fiscal Year 2024-2025. On February 23, 2021, this ITN was awarded to Orlando Telephone Company, Inc. d/b/a Summit Broadband, Inc. in Orlando, FL, for a three-year period, beginning July 1, 2021, through June 30, 2024, with renewal options for three additional one-year periods, upon the written agreement of the vendor and the District.
