Approval to renew ITN No. N207392RC for Generators - Purchase, Maintenance and Repair awarded to Accurate Power and Technology, Inc. of Eustis, FL, for the first renewal period of May 25, 2024 through May 24, 2025, for up to \$750,000.00, pursuant to the same terms and conditions as previously approved by the Board. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N207392RC is for Generators - Purchase, Maintenance and Repair. Services include District-wide emergency generator repairs and routine maintenance on large-scale emergency generators at District shelter facilities; as well as, the option to rent and purchase new generators. On May 25, 2021, this ITN was awarded to Absolute Telecom & Electric, LLC of Hialeah, FL, Accurate Power and Technology, Inc. of Eustis, FL, and Taylor Sudden Service, Inc. of Louisville, MS, for a three-year period, beginning May 25, 2021 through May 24, 2024, with renewal options for three additional one-year periods, upon the written agreement of the vendors and the District. The anticipated projects include, but are not limited to:

- \$200,000.00 Maintenance Services Day to Day repairs Capital Funds
- \$150,000.00 Colonial Elementary School Capital Funds
- \$150,000.00 Transportation Mid-South Capital Funds
- \$150,000.00 Varsity Lakes Middle School Capital Funds
- \$50,000.00 Manatee Elementary School Capital Funds (Removal of old generator)
- \$50,000.00 Treeline Elementary School Capital Funds (Removal of old generator)

It is recommended the Board approve the renewal with Accurate Power and Technology, Inc. of Eustis, FL, for the first renewal period of May 25, 2024 through May 24, 2025, for up to \$750,000.00, pursuant to the same terms and conditions as previously approved by the Board. Absolute Telecom & Electric, LLC of Hialeah, FL and Taylor Sudden Service, Inc. of Louisville, MS, did not respond to the renewal request.
