The increase of up to \$6,250,000.00 will be funded from budgeted Maintenance Services Department funds. This agenda item is specifically for a one-time approval to increase the previously Board approved amount of \$3,200,000.00 by \$6,250,000.00, for up to \$9,450,000.00. Funds will only be expended within the existing resources of the applicable location.

Approval to increase the previously Board approved amount of \$3,200,000.00 by \$6,250,000.00, for up to \$9,450,000.00, with Gatewood Glass, Recommended Action

Inc. in Fort Myers, FL for the period of March 26, 2024 through June 12, 2024, pursuant to the same terms and conditions as previously approved by the Board. The \$6,250,000.00 increase is requested because Maintenance Services has identified additional projects that were requested in the

Capital Plan that was approved in December, 2023. Approval authorizes the Superintendent to execute all related documents.

Invitation to Negotiate No. N237443DO is for Glazing Materials, Repairs and Installation Services and products include repair and installation of plate glass, tempered glass, hurricane impact glass, storefront doors, and curtain walls for District buildings on an as-needed basis. On June 13, 2023, the School Board of Lee County approved this ITN, awarded to Gatewood Glass, Inc. in Fort Myers, FL, beginning June 13, 2023 through June 12, 2024. The \$6,250,000.00 increase is requested because Maintenance Services identified additional projects that were requested in the Capital Plan that was approved in December 2023. The anticipated projects include, but are not limited to:

- \$2,600,000.00 The Alva School: Window Upgrades (Capital Funds)
 \$2,200,000.00 Fort Myers High School: Window Upgrades, Building No. 1 (Capital Funds)
 \$1,450,000.00 Pelican Elementary School: Window Upgrades, Building No. 6 and 7 (Capital Funds)

It is recommended the Board approve the increase to the previously Board approved expenditure amount of \$3,200,000.00, by \$6,250,000.00, for up to \$9,450,000.00, with Gatewood Glass, Inc. in Fort Myers, FL, for the period of March 26, 2024 through June 12, 2024, pursuant to the same terms and conditions as previously approved by the Board.
