(Jacksonville, FL), and The Sherwin-Williams Company (Bradenton, FL), for the period of August 8, 2023 through July 31, 2024, for up to \$200,000.00, with an option to cancel if deemed to be in the best interest of the District. This contract enables the Maintenance Services Department to purchase paint, sealer, spray paints, paint thinner, brushes, rollers, caulk and other miscellaneous paint supplies at volume discounts. A separate contract is in place for painting services, and this contract allows the District to purchase materials at a reduced rate for scheduled painting projects.

Approval authorizes the Superintendent to execute all related documents.

The School District of Manatee County, for Bid No. 22-0050-MR - Paint and Paint Supplies, was awarded to Florida Paints & Coatings, LLC (Sarasota FL), The Pioneer Manufacturing Company (Cleveland, OH and Orlando, FL), PPG Architectural Finishes, Inc. (Jacksonville, FL), and The Sherwin-Williams Company (Bradenton, FL) for the period of August 1, 2021 through July 31, 2024 and renewed through July 31, 2026. This contract enables the Maintenance Services Department to purchase paint, sealer, spray paints, paint thinner, brushes, rollers, caulk and other miscellaneous paint supplies at volume discounts. A separate contract is in place for painting services, and this contract allows the District to purchase materials at a reduced rate for scheduled painting projects. It is recommended the Board approve this piggyback, for up to \$200,000.00, for the period of August 8, 2023 through July 31, 2024, with an option to cancel if deemed to be in the best interest of the District.
