Budget Source The increase of up to \$300,000.00, and the request to renew the contract in the

amount of up to \$2,600,000.00, will be funded from budgeted School/Department funds. This agenda item is specifically for a one-time approval to increase the previously Board approved amount of \$800,000.00 by \$300,000.00, and for the Piggyback of the contract in the amount of \$2,600,000.00 for a total amount up to \$2,900,000.00. Funds will only be expended within the existing resources of the

applicable locations.

Recommended Action

Approval to Increase Expenditure and to Piggyback the Prince William County Public Schools Contract No. R-TC-17006 – On-line Marketplace for Purchase of Products and Services through Amazon Services, LLC of Seattle, WA with location in Lee County, FL. This contract supports the purchase of office supplies, classroom supplies, art supplies, books, musical instruments, audiovisuals, electronics, secondary education scientific equipment and lab supplies, as well as hard to find items. Two actions are recommended.

1. It is recommended the Board approve an increase to the previously Board approved amount of \$800,000.00 by \$300,000.00, for up to \$1,100,000.00, for the period of December 5, 2023 through January 18, 2024. The one-time increase of \$300,000.00 is requested due to increased orders on Amazon from new P-Card holders in District schools and departments, including orders from Infrastructure Services for computer memory sticks and other computer components.

2. It is also recommended the Board approve this Piggyback for a period not to exceed one year, commencing on the date of the renewal of the contract by the Prince William County Public Schools, for up to \$2,600,000.00, with an option to cancel if deemed to be in the best interest of the District. Approval authorizes the

Superintendent to execute all related documents.

Piggyback No. Prince William County Public Schools Contract No. R-TC-17006 is for On-line Marketplace for Purchase of Products and Services through Amazon Services, LLC, Seattle, WA. This contract supports the purchase of office supplies, classroom supplies, art supplies, books, musical instruments, audiovisuals, electronics, secondary education scientific equipment and lab supplies, as well as hard to find items. On January 19, 2017 this Piggyback was awarded to Amazon Services, LLC of Seattle, WA with location in Lee County, FL, for a five-year period beginning January 19, 2017 through January 18, 2022, and renewed through January 18, 2024, with two more two-year renewals available. Two actions are recommended:

1. It is recommended the Board approve an increase to the previously Board approved amount of \$800,000.00 by \$300,000.00, for up to \$1,100,000.00, for the period of December 5, 2023 through January 18, 2024. The one-time
