Budget Source There is no cost to the District for Voluntary Group Vision Insurance. This agenda item is

specifically for the approval of the award. Employees who elect this benefit pay for it themselves

through payroll deductions.

Recommended Action

Approval to award ITN No. N237450AN for Voluntary Group Vision Insurance, to Avesis, LLC, as indicated on the attached tabulation sheet. This ITN will be effective for four years, beginning April 1, 2024 through March 31, 2028, with renewal options for two additional two-year periods, upon the written agreement of the vendor and the District. The School Board of Lee County offers employees working twenty (20) or more hours per week, in a regular position, a menu of voluntary (employee paid) benefits. Vision related services include vision exams, contact lens and frame allowances, and additional lens features. The Insurance Task Force (ITF) subcommittee, comprised of ITF members, including representatives from Insurance and Benefits Management and the Florida Education Association, reviewed the scoring committee recommendation in their September 7, 2023 meeting. Approval authorizes the Superintendent

to execute all related documents.

Invitation to Negotiate No. N237450AN is for Voluntary Group Vision Insurance. The School Board of Lee County offers employees working twenty (20) or more hours per week, in a regular position, a menu of voluntary (employee paid) benefits. Vision related services include vision exams, contact lens and frame allowances, and additional lens features. The Insurance Task Force (ITF) subcommittee, comprised of ITF members, including representatives from Insurance and Benefits Management and the Florida Education Association, reviewed the scoring committee recommendation in their September 7, 2023 meeting. It is recommended the award be made to Avesis, LLC, as indicated on the attached tabulation sheet, effective for four years, beginning April 1, 2024 through March 31, 2028, with renewal options for two additional two-year periods. Fifteen (15) vendors were notified of the ITN, ten (10) vendors submitted a response, one (1) vendor was deemed non-responsive and five (5) vendors did not respond.
