Goals Strategic Priority: Improving Internal Operating Systems

Brevard County Public Schools ITB #20-415-B-SH, for Intercom & System Products & Related Services, was awarded to multiple vendors including Rauland-Borg Corporation of Florida, in Fort Myers, FL, for the period of April 15, 2020 through April 14, 2023 and renewed through April 14, 2025. This contract supports the Maintenance Services Department for the purchase of products and services including, but not limited to, intercom systems.
