- Elementary does fall and spring - curriculum night, meet teacher night
- Mandatory versus voluntary is the issue
- There are usually 4-5 mandatory events
- Could use TBD
- Some elementary schools have active PTOs/PTAs that really push events
- Calendar committees should add tbd to school calendar

## Article 7 - Length of Meetings

- Restriction of length of meetings and intention it applies after contract hours
- Proposal intent - 45 minutes in duration for each meeting
- Two meetings a month in afternoons that extend beyond contract
- There is a hard stop

Options

1. At schools where there are 2 meetings per month and they extend past contract time, the meetings must have a hard stop.
2. Add - PM faculty meetings should not extend 45 minutes past the contract day.

## Article 7 - PLCs

- 7.01(1)(d) - Limitation of 30 minutes
- Quite restrictive to school administrators
- Each school does PLCs differently
- District data shows that PLCs should be 40-60 minutes each to prove beneficial


## District Caucus Report

- Discussed PLC options and unintended consequences
- Some middle schools have 60-minute PLCs during contract hours
- Teachers are still getting 350 minutes of planning
- It is a directive to participate in PLCs because the teachers asked for training from district employees
- Middle school has the luxury of 350 minutes of planning a week
- Who is driving the meeting
- If teachers finish the PLC early, can they leave early


## TALC Caucus Report

- PLCs and planning are all over the place
- With all the unknowns wants to test status quo


## Options

4. PLCs should last no longer than a planning period.
